



**COLLABORATIVE AGREEMENT**  
**BETWEEN**  
**FUNDACIÓN PARA EL FUTURO DE COLOMBIA**  
**AND**  
**ACCENT FRANÇAIS**

The *Fundación para el Futuro de Colombia* (COLFUTURO) and Accent Français share an interest in strengthening bilateral cooperation in the field of education between Colombia and France, promoting stronger ties between the two institutions to increase the administrative support and guidance available for French language studies of Colombian students.

The purpose of this agreement is to foster cooperation and enhance the links between the two institutions through the provision of shared administrative support for talented students admitted to the COLFUTURO Language Program (LP) at Accent Français held at Accent Français in Montpellier, France.

The mutual cooperation will operate as follows:

1. Colombian students interested in learning or improving their French language skills will seek admission to the COLFUTURO Language Program. Once students have been admitted and decided they would like to study at Accent Français, COLFUTURO will support them in their admissions processes to the French programs offered by institute in reference, following the normal application procedures and meeting all the standard admission requirements established by Accent Français.
2. Students admitted to the Language Program of COLFUTURO are responsible for the attainment of financial resources to cover their programs.
3. COLFUTURO will receive the students' payments in three different instalments and then make the international wire of the total cost of their program (one payment in full) directly to Accent Français's account which will have been previously determined. COLFUTURO will pay on the students' behalf before their programs have started. Some students may decide to pay other costs such as accommodation, meals plans, etc. directly to the university.
4. Accent Français will invoice COLFUTURO directly for each of the students admitted. The invoices will be prepared separately for each of our individual students and will have a breakdown for every item.
5. Accent Français will provide a partial scholarship of twenty percent (20%) in the value of tuition for any open enrolment French program at Accent Français to every student sent by the Language Program of COLFUTURO. This benefit will be maintained and/or extended for the time the student decides to study at Accent Français.
6. Accent Français will offer a 2-week Standard course as a scholarship to any open enrolment French program for every 20 students referred by COLFUTURO in the previous conditions mentioned. Accommodation is not included.

7. COLFUTURO will provide administrative support and guidance to the students with their admissions and visa processes. COLFUTURO will promote Accent Français open enrolment English programs at the institute centres mentioned above and the benefits agreed to by this mutual cooperation.
8. Each institution will designate a coordinator to implement and monitor this agreement. In particular, the designated coordinators will be responsible for ensuring that:
  - a. Accent Français and COLFUTURO provide prospective Colombian Language Program students with information on their programs of interest and guidance on how to apply to Accent Français.
  - b. Accent Français provides COLFUTURO with all the relevant promotional materials and brochures on the different English study programs offered by the universities mentioned to encourage interest among prospective Colombian students.
  - c. Accent Français provides all Colombian students admitted to their French language programs information on the Language Program of COLFUTURO and encourages these students to contact and submit an application to COLFUTURO.
  - d. COLFUTURO informs Accent Français of successful candidates by sending the list of Colombian students admitted to the Language Program of COLFUTURO. Furthermore, COLFUTURO will inform Accent Français if students decide to postpone or withdraw from any programs.
  - e. Both institutions have the obligation to inform the other party of any change in the designated coordinator or signatory in charge of this agreement.


10. Both institutions will promote the agreement to prospective Colombian French language students.
