

COLLABORATIVE AGREEMENT**BETWEEN****FUNDACIÓN PARA EL FUTURO DE COLOMBIA****AND****UQ COLLEGE LTD (UQC)**

The Fundación para el Futuro de Colombia (COLFUTURO) and UQ College Ltd, (UQC) share an interest in strengthening bilateral cooperation in the field of education between Colombia and Australia, promoting stronger ties between the two institutions to increase the administrative support and guidance available for English language studies of Colombian students.

The purpose of this agreement is to foster cooperation and enhance the links between the two institutions through the provision of shared administrative support for talented students admitted to the COLFUTURO Languages Program (LP) at UQC held at The University of Queensland St Lucia campus in Brisbane, Australia.

The mutual cooperation will operate as follows:

1. Colombian students interested in learning or improving their English languages skills will seek admission to COLFUTURO Languages Program. Once students have been admitted and decided they would like to study at UQC, COLFUTURO will support them in their admissions processes to the standalone English programs offered by UQC, following the normal application procedures and meeting all the standard admission requirements (waiving the application fee) established by the UQC.
2. Students admitted to the Languages Program of COLFUTURO are responsible for the attainment of financial resources to cover their programs.
3. COLFUTURO will make the international wire transfer of the total cost of their program (one payment in full) directly to the UQC account which had been previously determined. COLFUTURO will pay on the students' behalf before their programs have started. Students will pay accommodation and airport pick-up fees directly to third party providers and UQC may provide support in communication to the providers when necessary.
4. UQC will directly invoice COLFUTURO for each of the students admitted to UQC. The invoices would be individual for each of our students and would have a breakdown for every cost item.
5. UQC will provide a partial scholarship of ten percent (10%) in the value of tuition for standalone English language program at UQC to every student sent by the Languages Program of COLFUTURO. This benefit would be maintained or extended for the time the student decides to study at UQC.
6. UQC will offer a full tuition scholarship of five weeks to UQC standalone English language program for every 150 weeks referred from COLFUTURO in the previous conditions mentioned, within a contract year.
7. COLFUTURO will provide administrative support and guidance to the students with their admissions and visa processes. COLFUTURO will promote UQC programs and the benefits agreed by this mutual cooperation.

8. Each institution will designate a coordinator to implement and monitor this agreement. In particular, the designated coordinators will be responsible for ensuring that:

- a. UQC and COLFUTURO provide prospective Colombian Languages Program students with information on their programs of interest and guidance on how to apply to UQC.
- b. UQC provides COLFUTURO with all the relevant promotional materials and brochures on the different English language programs offered by UQC to encourage interest among prospective Colombian students.
- c. COLFUTURO informs the UQC of successful candidates by sending the list of Colombian students admitted to Languages Program of COLFUTURO. Furthermore, COLFUTURO will inform if students decide to postpone or withdraw of either program.
- d. Both institutions have the obligation to inform the other party of any changes in the designated coordinator or signatory in charge of this agreement.



This agreement shall remain in force from the date of signature by the designated representatives of each party and may be reviewed or renegotiated at the request of either party. Either party may terminate the agreement by providing at least thirty days prior written notice to the other party.
