



**COLLABORATIVE AGREEMENT**  
**BETWEEN**  
**FUNDACIÓN PARA EL FUTURO DE COLOMBIA**  
**AND**  
**ACE ENGLISH MALTA**

The *Fundación para el Futuro de Colombia* (COLFUTURO) and ACE ENGLISH MALTA share an interest in strengthening bilateral cooperation in the field of education between Colombia and Malta, promoting stronger ties between the two institutions to increase the administrative support and guidance available for English language studies of Colombian students.

The purpose of this agreement is to foster cooperation and enhance the links between the two institutions through the provision of shared administrative support for talented students admitted to the COLFUTURO Language Program (LP) at ACE ENGLISH MALTA held at Bay Street shopping centre in Saint Julians, Malta.

The mutual cooperation will operate as follows:

1. Colombian students interested in learning or improving their English language skills will seek admission to the COLFUTURO Language Program. Once students have been admitted and decided they would like to study at ACE ENGLISH MALTA, COLFUTURO will support them in their admissions processes to the English programs offered by the English school in reference, following the normal application procedures and meeting all the standard admission requirements and, terms and conditions (waiving the application fee) established by ACE English Malta.
2. Students admitted to the Language Program of COLFUTURO are responsible for the attainment of financial resources to cover their programs.
3. COLFUTURO will receive the students' payments in three different instalments and then make the international wire of the total cost of their program (one payment in full) directly to ACE ENGLISH MALTA account which will have been previously determined. COLFUTURO will pay on the students' behalf before their programs have started, at least more than 4 weeks prior the arrival, and before visa application date when this process is required. The student pays the fee for checking documents and appointment fee for visa process. Some students may decide to pay other costs such as accommodation, meals plans, etc. directly to the university.
4. ACE ENGLISH MALTA will invoice COLFUTURO directly for each of the students admitted. The invoices will be prepared separately for each of our individual students and will have a breakdown for every item.

5. ACE ENGLISH MALTA will provide a partial scholarship of 25 percent (25%) in the value of tuition for any open enrolment English program at ACE ENGLISH MALTA name to every student sent by the Language Program of COLFUTURO. This benefit will be maintained and/or extended for the time the student decides to study at ACE English Malta.
6. ACE English Malta will offer a full tuition scholarship for a 12-week General or Intensive English Course subject to the following conditions:
  - Colfuturo must refer a minimum of 40 students for ACE open group courses with a duration of at least 12 weeks.
  - All 40 enrolments must be paid in full.
  - All 40 students must have started their courses.
  - Additional services are not included in the scholarship.
7. COLFUTURO will provide administrative support and guidance to the students with their admissions and visa processes. COLFUTURO will promote ACE English Malta open enrolment English programs, and the benefits agreed to by this mutual cooperation.
8. Each institution will designate a coordinator to implement and monitor this agreement. In particular, the designated coordinators will be responsible for ensuring that:
  - a. ACE ENGLISH MALTA and COLFUTURO provide prospective Colombian Language Program students with information on their programs of interest and guidance on how to apply to ACE ENGLISH MALTA
  - b. ACE ENGLISH MALTA provides COLFUTURO with all the relevant promotional materials and brochures on the different English study programs offered by ACE ENGLISH MALTA to encourage interest among prospective Colombian students.
  - c. COLFUTURO informs ACE ENGLISH MALTA of successful candidates by sending the application form of each student admitted to the Language Program of COLFUTURO. Furthermore, COLFUTURO will inform ACE ENGLISH MALTA if students decide to postpone or withdraw from any programs.
  - d. Both institutions have the obligation to inform the other party of any change in the designated coordinator or signatory in charge of this agreement.
9. The designated coordinators are:

10. ACE ENGLISH MALTA and COLFUTURO will indirectly promote each other.


