



PROGRAM AGREEMENT
BETWEEN
FUNDACIÓN PARA EL FUTURO DE COLOMBIA
AND
UNIVERSITY OF CENTRAL FLORIDA BOARD OF TRUSTEES
For the benefit of UCF Global

The Fundación para el Futuro de Colombia (COLFUTURO) and the University of Central Florida Board of Trustees (UCF) for the benefit of UCF Global (UCF Global) share an interest in strengthening bilateral cooperation in the field of education between Colombia and the United States of America, promoting stronger ties between the two institutions to increase the administrative support and guidance available for English language studies of Colombian students.

The purpose of this agreement is to foster cooperation and enhance the links between the two institutions through the provision of shared administrative support for talented students admitted to UCF Global's English Language Programs (i.e., Online English Program; Intensive English Program).

The mutual cooperation will operate as follows:

1. Colombian students interested in learning or improving their English language skills will seek admission to UCF Global's English Language Programs via COLFUTURO. Once students have been admitted and decided they would like to study with UCF Global, COLFUTURO will support them in their admissions processes to the English programs offered by UCF Global, following the normal application procedures and meeting all the standard admission requirements (waiving the application fee) established by UCF and UCF Global.
2. Students admitted to UCF Global's English Language Programs are responsible for the attainment of necessary financial resources to cover the required costs associated with their programs.
3. COLFUTURO will receive the students' payments in three different instalments and then make the international wire of the total cost of their program (one payment in full) directly to UCF, which will have been previously determined. COLFUTURO will pay on the students' behalf before their programs have started. Some students may decide to pay other costs such as accommodation, meal plans, etc. directly to the university.
4. UCF Global will invoice COLFUTURO directly for each of the students admitted to UCF Global's English Programs. The invoices will be prepared separately for each individual student and will have a cost breakdown for every item.
5. UCF Global will provide discounts to COLFUTURO students as follows:
 - a. A discount of twenty percent (20%) in the value of tuition for any open enrolment of UCF Global's Online English Program to every student sent by COLFUTURO. This benefit will be maintained and/or extended for the time the student decides to study in UCF Global's Online English program.
 - b. A discount of thirty percent (30%) in the value of tuition for any open enrolment of UCF Global's Intensive English Program to every student sent by COLFUTURO. This benefit

- will be maintained and/or extended for the time the student decides to study in UCF Global's Intensive English program.
- c. UCF Global will offer a full tuition discount to one (1) COLFUTURO student to any open enrolment English program (either UCF Global's Online English Program or UCF Global's Intensive English Program) for every 20 students referred by COLFUTURO in the previous conditions mentioned.
6. COLFUTURO will provide administrative support and guidance to the students with their admissions and visa processes. COLFUTURO will promote UCF Global's open enrolment English Language Programs at the university centres mentioned above and the benefits agreed to by this mutual cooperation.
 7. Each institution will designate a coordinator to implement and monitor this agreement. In particular, the designated coordinators will be responsible for ensuring that:
 - a. UCF Global and COLFUTURO provide prospective Colombian Language Program students with information on their programs of interest and guidance on how to apply to UCF Global's English Language Programs.
 - b. UCF Global provides COLFUTURO with all the relevant promotional materials and brochures on the different English Language Programs offered by the universities mentioned to encourage interest among prospective Colombian students.
 - c. COLFUTURO informs UCF Global of successful candidates by sending the list of Colombian students. Furthermore, COLFUTURO will inform UCF Global if students decide to postpone or withdraw from any programs.
 - d. Both institutions have the obligation to inform the other party of any change in the designated coordinator or signatory in charge of this agreement.

9. Both institutions will promote the agreement to prospective Colombian English language students.

This agreement shall remain in force for a period of three (3) years from the date of signature by the designated representatives of each party and may be reviewed or renegotiated at the request of either party. Either party may terminate the agreement by providing at least thirty (30) days prior written notice to the other party.
